



## **TERMS OF REFERENCE FOR THE CONSULTANCY TO LOCALISE SUSTAINABLE DEVELOPMENT GOAL (SDG) 6.1 AND 6.2 IN UGANDA**

### **Introduction**

Uganda was one of the first countries in the world to adopt the SDGs in their national planning frameworks and strategies. The just concluded National Development Plan II (NDP II 2015-2016- 2019/20) adopted over 85% of the SDGs by end of 2015 and the 3<sup>rd</sup> National Development Plan (NDP III 2020/21- 2024/25) has fully embraced the SDGs goals and indicators in its strategic objectives

In 2015, the Ministry of Water and Environment piloted the development of SDG indicators 6.3 to 6.5 and contributed to the interpretation of targets globally.

SDG 6. Is in ensuring the availability of water and sanitation for all and targets 6.1 is on access to clean water and 6.2 on sanitation

Specifically, 6.1 states ““By 2030, achieve universal and equitable access to safe and affordable drinking water for all” and 6.2 states “By 2030, achieve access to adequate and equitable sanitation and hygiene for all and end open defecation, paying special attention to the needs of women and girls and those in vulnerable situations”

These indicators are further measured in terms of safely managed, basic, limited, unimproved and surface water services while for sanitation the service indicators are measured in terms safely managed, basic, limited, unimproved and open defecation.

The ministry of Water and Environment in 2018 upgraded her performance indicators to incorporate SDG Target and UWASNET also update the CSO reporting tool to incorporate the revised MWE performance indicators.

Despite the existence of these indicators, studies and assessments have revealed that CSOs and citizens have limited understanding and interpretation of these indicators in their local context.

UWASNET would like to commission a consultancy to localise SDG 6.1 and 6.2

### **Overall Objective of the Consultancy**

The overall objective of this consultancy is to develop localized indicators for SDG 6.1 and 6.2 in a pictorial form

### **Detailed TORs**

The detailed TORs of this consultancy will be

1. Develop a pictorial interpretation of SDG 6.1 and 6.2 in terms of service indicators
2. Share the developed concept with the with UWASNET for approval
3. Develop a final out put ready for printing

### **Specific tasks**

The consultant/ Firm will be required to undertake the following tasks:

- Familiarize him/herself with SDG 6.1 and 6.2 have been interpreted in Uganda
- Review the revised MWE performance indicators relating to water supply and sanitation
- Develop a pictorial interpretation of the localized SDG indicators

### **Deliverables/Expected Outputs**

The major expected outputs of the consultancy include:

- Technical and financial proposal
- A draft localized pictorial developed and presented for approval
- A final product ready for printing
- A final report of the process and out comes
